### 1. Definition of "AXM Plus"

AX Manager Plus is a management software for managing locking systems and offers the following functions:

Single-user version with basic license and software application contract
Management of offline components, online optional
Local installation of the software and data on a computer
Management of locking systems with up to 64,000 transponders, 64,000 locking devices, 100 time groups
Use of multiple locking systems
Ergonomic data entry using function assistants (e.g. creating a new identification medium)
Support for active and/or passive media and locking components, AX2Go optional
Support for MIFARE®
Areas and groups for mapping building and organizational structures (first level)
Matrix display enables quick and easy editing
Transfer of existing locking plans (CSV import)
Basis for further expansion of the system
Upgrade to a more powerful edition possible
Option to use cloud services for extensions

### 2. AX2Go

#### 2.1 Definition of "AX2Go"

AX2Go is a mobile key for opening SimonsVoss digital locking components via Bluetooth Low Energy (BLE). If the locking authorizations are stored in the AX2Go app, the smartphone can be used like an access card or a transponder.

Cloud services are responsible for transferring the mobile keys from the management software to the smartphone, which route the data packets and also report back the successful transfer. This cloud service is called "AX2Go Service" in the management software. All data packets are end-to-end encrypted.

The AX2Go solution contains the following functions and has the following features:

---

AX2Go app is available for the iOS and Android operating systems
Communication between smartphone and lock takes place via Bluetooth Low Energy
Transfer key authorizations via e-mail, SMS or QR code from the management software
Multiple locking systems (AX2Go keys) on one smartphone
Automatic updating of mobile keys with an existing Internet connection
12 months software fee (AXM.AX2GO.XX.SF) must be purchased additionally

## 2.2 Bookable packages

The mobile keys can be booked in packages and freely combined. Please also refer to the price list, which can be found under [Contractual documents](#).

- AX2Go 10 option: Enables the simultaneous use of 10 mobile end devices to open authorized AX locking devices
- AX2Go 25 option: Enables the simultaneous use of 10 mobile end devices to open authorized AX locking devices
- AX2Go 50 option: Enables the simultaneous use of 10 mobile end devices to open authorized AX locking devices
- AX2Go 100 option: Enables the simultaneous use of 10 mobile end devices to open authorized AX locking devices
- AX2Go 500 option: Enables the simultaneous use of 10 mobile end devices to open authorized AX locking devices
- AX2Go 1000 option: Enables the simultaneous use of 10 mobile end devices to open authorized AX locking devices

The underlying license model is so-called "floating licenses". This means that, for example, in a package of 10 AX2Go keys, 10 mobile keys can also be active on 10 end devices at the same time. Only when one of these is blocked can a new one be created.
